OSHA (Occupational Safety and Health Administration) is the agency that was created to ensure safe working conditions for workers by setting and enforcing a series of rigorous standards. The 30-hour course is designed for supervisors or workers with some safety responsibility and covers a much wider range of topics. Upon course completion, learners will receive an official Department of Labor (DOL) OSHA card.
